Recommendation

It is recommended that the Board of Supervisors approve the settlement of the legal action entitled Jane Doe v. San Joaquin County, et al.: Eastern District Court Case No. 2:18-CV-00667-TLN-AC in the amount of \$195,000.

Reason for Recommendation

Plaintiff claims that she was sexually harassed by a Sheriff's Deputy over the course of approximately three months while incarcerated at San Joaquin County Jail. Plaintiff filed suit for violations of civil rights, Sexual Harassment, and several other causes of action.

While the County disputes the allegations, it has been determined that timely economic resolution together with release of any and all potential claims is in the best interests of the County. Pursuant to the authority previously rendered by the Board, the

Office of the County Counsel has negotiated a settlement of this case in the amount of \$195,000.

Fiscal Impact

The sum of \$195,000 will be paid out of the Self-Insurance Trust Fund.

Action to Be Taken Following Approval

The County Auditor-Controller is to draw a warrant at this time payable as follows:


